## Dear Delegates,

Welcome to the **Command Area Development & Water Management (CADWM)** Conference at Ahmedabad jointly organized by **'Union Ministry of Water Resources, River Development & Ganga Rejuvenation' and 'Sardar Sarovar Narmada Nigam Ltd'.** This one-day (28<sup>th</sup> May 2019) event is the second in the series of National CADWM Conferences planned to be held in different States each year as per resolution adopted in the first CADWM Conference held on 13<sup>th</sup> March 2018 at New Delhi.

The deliberations planned for the 2<sup>nd</sup> CADWM Conference are primarily spread over three technical sessions covering:

- (i) Program Review Success, Failure, and Strategic Corrections;
- (ii) Structural Intervention Adaptation of New Technologies; and
- (iii) Non-structural Intervention Sustaining 'Participatory Irrigation Management' Initiative.

The esteemed Chairs and Speakers of these Sessions, coming from different backgrounds and working in different ways, will share their valuable experiences on varied key concerns (implementation bottlenecks, cost aspects, contractual issues, quality and speed of survey/planning, faults in implementation, capacity building of WUAs, conjunctive use of groundwater, new materials/ technologies etc). The question-answer round at the end of each Session will add further value to the deliberations. The Conference outcomes (to be summarized as Conference Recommendations) are expected to help us in collectively and impartially reviewing the successes and failures of the ongoing CADWM Program, learn from the best practices, and seek course corrections in our future interventions.
